Sir Cyril Chantler is Chairman of the Board of the Great Ormond Street Hospital for Children NHS Trust and of the Kings Fund, London. He is Chairman of the Beit Memorial Fellowships Board and of the Clinical Advisory Committee for NHS London. He is a trustee of the Dunhill Medical Trust, a member of the Council of Southwark Cathedral and a member of the Editorial Board of the Journal of the American Medical Association. He is an adviser to the Associate Parliamentary Health Group. 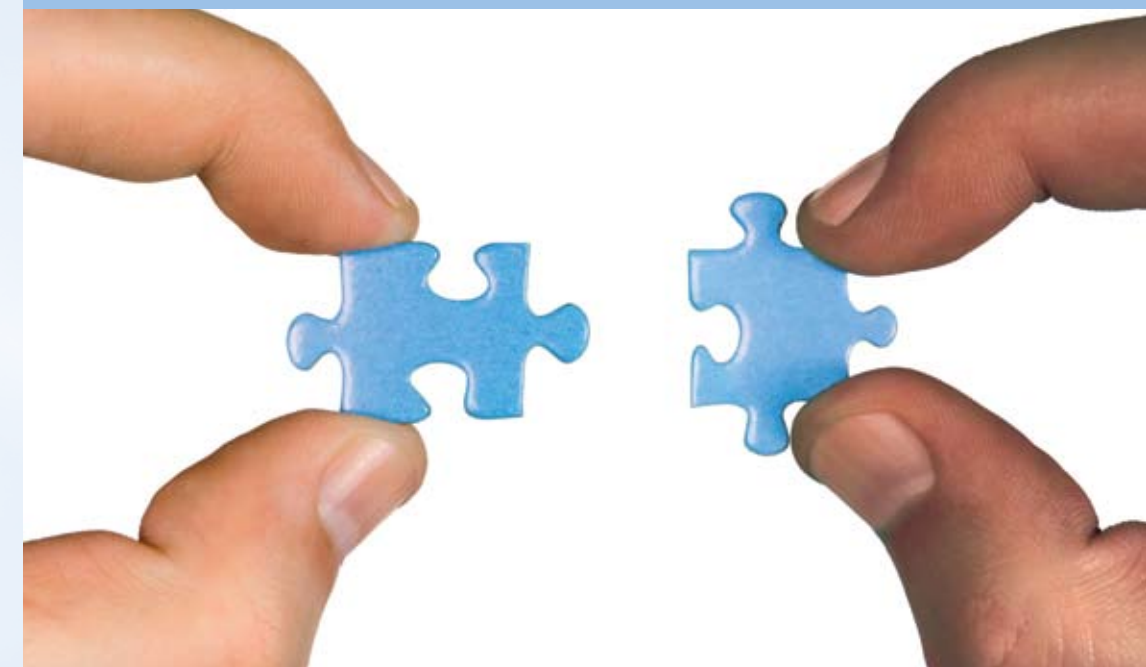

CONFERENCE

At the present time there is widespread concern across NHS institutions about how best to safeguard and cultivate the core professional values that are the lifeblood of its ethos. Concerns about how to foster and safeguard professionalism are evident within other healthcare professions than medicine. The questions raised are profound, going to the heart of the vocation to serve others in healthcare and the self understanding of professionals within the NHS. Many have called for a wider debate about the future of medical professionalism – and healthcare professionalism more generally – as a public good, and as a service to the common good of society. The Christian Churches in England and Wales bring to this debate both the wisdom of experience of their teaching and action down the centuries, reflected in the many charitable activities which did much to lay the foundations on which today's NHS is built. The Churches continue to be present in today's NHS through the employment of many people of Christian faiths at all levels and in all professions within the NHS, as well as through the distinctive and important ministry of healthcare chaplaincy.

The Bishops' Conference has recently engaged in a number of initiatives in conjunction with the Catholic Guilds for healthcare professionals to support the Catholic Church's healthcare ministry in England and Wales. Publications on Healthcare Chaplaincy, and on Caring for the Catholic patient, have sought to address the practical needs of chaplains and NHS Trusts, and the spiritual needs of patients. It has become clear that there is a desire amongst many Christian healthcare professionals to find opportunities to better integrate their faith and their work.

Are you a Healthcare professional concerned about the dilemmas facing you in your work today?

The Conference will bring together healthcare professionals from across the country, and will further the current public debate about vocation and professionalism within the NHS by considering the experience of Christians working in healthcare and by providing a space for healthcare professionals to reflect on the spiritual basis of their vocation to work in healthcare, and to be renewed and affirmed in it. There will be plenary and parallel sessions and a conference dinner on 4th July.

The conference is open to healthcare professionals of all faiths and none.
